14 AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
15 Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'odham Nation,
16 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
17 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984).


