1 **WHEREAS, the Chukut Kuk District Council did meet on August 22, 2011 in San Miguel at which**
2 **a quorum was present; and**

3 **WHEREAS, FY2011 Budget Amendment No. 5 was approved by Chukut Kuk District Council**
4 **Resolution No. 2011-64; and**

5 **WHEREAS, the amount of \$64,497.31 will be transferred from various line items to cover**
6 **expenditure of funds and projected costs for the remainder of FY2011; and**

7 **WHEREAS, the Chukut Kuk District Council did review and approve San Miguel community**
8 **FY2011 budget amendment No. 1, by Resolution No. 2011-58; and**

9 **WHEREAS, the amount of \$1,000.00 will be taken from line item 860 - Special Activities and**
10 **\$1,000.00 will be taken from line item 850-Food and transferred to line item 612-**
11 **Occasional Appointment; and**

12 **WHEREAS, the total amount of \$2,000.00 will be transferred to line item 612-Occasional**
13 **Appointment to cover anticipated costs; and**

14 **WHEREAS, Chukut Kuk District FY2011 Budget Amendment No. 5 has been presented to the**
15 **Legislative Council Budget & Finance Committee for review.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **Chukut Kuk District FY2011 Budget Amendment No. 5 attached hereto and**
18 **incorporated herein.**

19 **BE IT FURTHER RESOLVED that the amount of \$66,497.31 will be taken from savings and added to**
20 **line item 810 - Professional Services to cover anticipated costs.**

21 **BE IT FURTHER RESOLVED that the total amount of \$66,497.31 will be transferred to various**
22 **line items to cover expenditure of funds and projected costs for the remainder of**
23 **FY2011.**

24 **\$20,800.00 will be transferred from line item 610 - Salaries**

25 **\$11,423.26 will be transferred from line item 610 - Salaries**

26 **\$11,239.21 will be transferred from line item 620- Fringe Benefits**

27 **\$4,500.00 will be transferred from line item 624 - Bonus**

28 **\$12,980.29 will be transferred from line item 780-Contingencies**

29 **\$554.55 will be transferred from line item 852 Donation/Contribution**

30 **\$5,000.00 will be transferred from line item 866-Emergencies**






