

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting September 28, 2011 Special Session to Address the FY 2012 District Budgets)**

LEGISLATIVE ORDER NO. 11-423

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and

5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with  
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the  
7 Tohono O'odham Legislative Council, Article I, Section 1, (D)(1)); and

8 WHEREAS, the Legislative Council Budget and Finance Committee has requested a special session  
9 on September 28, 2011 to address the FY 2012 district budgets.

10 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a  
11 special session on September 28, 2011 to address the FY 2012 district budgets.

12 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> day of  
13 SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article  
15 VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
16 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
18 Stat. 984).


