(Approving an Attorney Contract for FY 2011-2012 with the Law Firm of SNR
Denton US LLP)**

RESOLUTION NO. 11-433

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of SNR Denton**
2 **US LLP to represent the Tohono O'odham Nation in matters relating to the West Valley**
3 **Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract with SNR Denton for**
5 **fiscal years 2011-2012 for the period from September 6, 2011 to September 30, 2012;**
6 **and**

7 **WHEREAS, the funding for this Attorney Contract will come from the FY 2012 Economic**
8 **Development Budget; and**


9 **WHEREAS, the Economic Development Delegation, the Domestic Affairs Committee and the**
10 **Budget and Finance Committee have reviewed this attorney contract and recommend**
11 **approval by the Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**
14 **law firm of SNR Denton US LLP for FY 2011-2012, for the period from September 6,**
15 **2011 to September 30, 2012, substantially in the form attached hereto.**
- 16 **2. Funding for the Attorney Contract will come from the FY 2012 Economic**
17 **Development Budget.**
- 18 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
19 **Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
21 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
