

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Governmental Relations Representation Contract with
Triadvocates, LLC)

RESOLUTION NO. 11-436

1 **WHEREAS, the Legislative Council is vested with the authority to "consult, negotiate and conclude**
2 **agreements and contracts on behalf of the Tohono O'odham Nation with Federal, State**
3 **and local governments and other Indian tribes or their departments, agencies, or**
4 **political subdivisions, or with private persons or organizations on all matters within**
5 **the authority of the Tohono O'odham Council" (Tohono O'odham Constitution, Article**
6 **VI, Section 1(f)); and**

7 **WHEREAS, the Legislative Council approved the FY 2012 Executive Branch Administrative Lobby**
8 **Budget, line item 811-Lobby, which funds federal and state lobbying services; and**

9 **WHEREAS, the Nation's Chairperson, in consultation with the Appropriations Committee,**
10 **recommends that Triadvocates, LLC be retained as a governmental relations**
11 **consultant for matters involving State of Arizona legislative, administrative,**
12 **appropriations, lobbying, and agency activities, as well as State of Arizona local and**
13 **municipal governmental activities, that may affect the Nation in accordance with the**
14 **attached Governmental Relations Representation Contract with Triadvocates, LLC**
15 **("Contract") for the period commencing October 1, 2011 and ending September 30,**
16 **2012.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 18 **1. Approves the Contract with Triadvocates, LLC in the amount of \$180,000 for the**
19 **period commencing October 1, 2011 and ending September 30, 2012 in**
20 **substantially the form attached hereto; provided that the Contract shall be**
21 **funded from the FY 2012 Executive Branch Administrative Lobby Budget, line item**
22 **811-Lobby.**
- 23 **2. Authorizes the Nation's Chairperson to execute the Contract.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
25 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
