

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2011-FY2012 with the Law Firm of Ater
Wynne, LLP)**

RESOLUTION NO. 11-444

1 **WHEREAS, the Office of Attorney General requires the legal services of the Ater Wynne law firm**
2 **to represent the Tohono O'odham Nation in matters relating to the establishment of**
3 **a Section 17 corporation; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$10,000.00 for the period from**
5 **September 1, 2011 to September 30, 2012; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the FY 2012 Planning and**
7 **Economic Development Department Budget; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney**
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**
12 **Ater Wynne law firm in the amount of \$10,000.00 for FY2011-FY2012, for the period**
13 **from September 1, 2011 to September 30, 2012, substantially in the form attached**
14 **hereto.**
- 15 **2. Funding for the Attorney Contract will come from the FY 2012 Planning and**
16 **Economic Development Department Budget.**
- 17 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
18 **Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
20 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
