

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Cooperative Agreement between the BIA and the Nation for  
Border Crime Investigations)**

**RESOLUTION NO. 11-446**

1 **WHEREAS, the Tohono O'odham Nation Police Department ("TOPD") seeks to enter into a**  
2 **Cooperative Agreement with the Bureau of Indian Affairs Office of Justice Services**  
3 **("BIA") for the cooperative use of qualified TOPD employees in investigating drug and**  
4 **human smuggling within the exterior boundaries of the Tohono O'odham Nation; and**


5 **WHEREAS, pursuant to the Cooperative Agreement, the BIA will provide: (1) funding and training**  
6 **for personnel within the TOPD Border Crimes Unit to conduct sensitive border crime**  
7 **investigations; and (2) investigative coordination and intelligence processing; and**

8 **WHEREAS, the attached Cooperative Agreement has been reviewed by the Domestic Affairs**  
9 **Committee which recommends Legislative Council approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the Cooperative Agreement with the Bureau of Indian Affairs Office of Justice Services,**  
12 **substantially in the form attached hereto, and authorizes the Chairman of the Nation**  
13 **to sign and execute the Agreement.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
15 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
16 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (f) and 1 (l) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
18 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**






