

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier District Budget for Fiscal Year 2011/2012)

RESOLUTION NO. 11-447

1 **WHEREAS, the San Xavier District (District) Administration developed and proposed a budget for**
2 **fiscal year ending on September 30, 2012; and**

3 **WHEREAS, the proposed FY 2012 District budget was reviewed by the District Council and its**
4 **Finance Committee, and District Development Managers at three special joint**
5 **meetings held on July 27, 2011, August 1, 2011 and August 8, 2011; and**

6 **WHEREAS, the San Xavier District Council intends to utilize its gaming revenues, interest earned**
7 **from the gaming funds, mining revenues and general operating funds to meet the**
8 **projected amount outlined in the attached fiscal year 2012 budget; and**

9 **WHEREAS, the proposed budget of \$13,715,427.42 was reviewed and discussed with the San Xavier**
10 **District members present at the Special District Community meeting held on August**
11 **20, 2011; and**

12 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee reviewed the District's**
13 **FY12 budget on September 26, 2011 and recommended that it be forwarded to the**
14 **Tohono O'odham Legislative Council for approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby with the**
16 **authority granted under the Tohono O'odham Constitution Article VI (d)(3) approves**
17 **the San Xavier District fiscal year 2012 budget in the amount of thirteen million seven**
18 **hundred fifteen thousand four hundred twenty-seven dollars and forty two cents,**
19 **utilizing its gaming revenues in the amount of three million eight hundred seventy**
20 **four thousand five hundred seventy six dollars and thirty cents; gaming fund interest**
21 **in the amount of eleven hundred eight dollars and fifty eight cents; mining revenues**
22 **in the amount of one hundred twenty six thousand nine hundred seventy one dollars**
23 **and two cents; and general operating funds in the amount of nine million seven**
24 **hundred twelve thousand seven hundred seventy one dollars and fifty two cents.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
26 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**


