

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Sif-Oidak District FY 2012 Gaming Revenue Budget in the  
Amount of \$1,660,996.79)**

RESOLUTION NO. 11-451

1 WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 11-308,  
2 "Appropriating Desert Diamond Savings to Supplement the FY 2012 Projected  
3 Revenues to the Nation and the Actual Gaming Distribution Revenue to the Districts  
4 in the amount of \$13,484,531.60"; and

5 WHEREAS, the Tohono O'odham Legislative Council also enacted Resolution No. 11-307,  
6 "Approving FY 2012 District Allocation and Apportionment of Gaming Distribution to  
7 the Districts by equal distribution"; and

8 WHEREAS, the apportionment for each of the Districts by equal distribution is in the amount of  
9 \$1,660,996.79; and

10 WHEREAS, the Sif-Oidak District Council on August 25, 2011 enacted Resolution No. SODC-11-166,  
11 Approving the FY 2012 Sif-Oidak District Gaming Revenue Budget in the amount of  
12 \$1,660,996.79; and

13 WHEREAS, on September 26, 2011, the Budget & Finance Committee of the Legislative Council  
14 reviewed the FY 2012 Sif-Oidak District Gaming Revenue Budget.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby  
16 approve the Sif-Oidak District FY 2012 Gaming Revenue Budget as attached in the  
17 amount of \$1,660,996.79.

18 BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding  
19 levels that it shall be approved by the Tohono O'odham Legislative Council prior to any  
20 expenditures.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day  
22 of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,457.45 FOR;  
23 122.45 AGAINST; 200.70[03] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the  
24 Council by Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation,  
25 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
26 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
27 of June 18, 1934 (48 Stat. 984).
