

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Gu-Vo District to Continue District Operations and Expenses Pursuant  
to FY 2011 Budget - Pending Approval of the Gu-Vo District FY' 2012 Budget)**

RESOLUTION NO. 11-453


1 WHEREAS, pursuant to the Tohono O'odham Nation Constitution Article VI, Section I - (d) 2, 3 the  
2 Tohono O'odham Council has the fiscal powers to manage funds, and to appropriate  
3 funds for the benefit of the Nation and its members, and to adopt, approve and amend  
4 annual budgets and to authorize the expenditure of funds...budgets; and

5 WHEREAS, the Tohono O'odham Legislative Council, in consideration of the request from the Gu-  
6 Vo District, have determined that it would be in the best interest of Gu-Vo District to  
7 continue district operations.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
9 Gu-Vo District's request to continue district operations and expenses pursuant to  
10 Tohono O'odham Legislative Council Resolution No. 10-366.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day  
12 of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
13 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
14 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by  
15 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984).
