

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Fiscal Year 2012 Budgets for Sells District Administration and  
its four Communities in the amount of \$1,660,996.79)**

**RESOLUTION NO. 11-455**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 11-307 approved the FY 2012**  
2 **District Allocation and Apportionment of Gaming Revenues to Districts by Equal**  
3 **Distribution in the amount of \$1,160,915.34 to each of the eleven Districts of the**  
4 **Tohono O'odham Nation; and**

5 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 11-308 also approved**  
6 **Appropriating Desert Diamond Savings to Supplement the FY 2012 Projected Revenues**  
7 **to the Nation and the Actual Gaming Distribution Revenues to the District in the**  
8 **amount of \$500,081.45 to each of the eleven Districts for a total allocation to the Sells**  
9 **District in the amount of \$1,660,996.79; and**

10 **WHEREAS, Sells District Administration did prepare and submit the attached Administration**  
11 **Budget to each of the four communities for their review and approval; and**

12 **WHEREAS, each of the four communities of Sells District have prepared and submitted attached**  
13 **community approved budgets in accordance to their needs; and**

14 **WHEREAS, Sells District Council did review and approve the FY 2012 Sells District Administration**  
15 **Budget and the attached budgets for each of the four communities of the Sells District**  
16 **with Resolution No. SD-97-11; and**

17 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee and the Tohono**  
18 **O'odham Legislative Council did review and approve Sells District Administration**  
19 **Budget and the budgets for each of the four communities.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Sells**  
21 **District Fiscal Year 2012 Budget for Administration and it's four communities as**  
22 **submitted in the attached budgets and it's justifications to be effective October 1, 2011**

7 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
8 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
9 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**  
10 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
12 **18, 1934 (48 Stat. 984).**
