

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 2 to the Intergovernmental Agreement with the
Arizona Department of Economic Security regarding the Title XX Grant)**

RESOLUTION NO. 11-457

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through grant funding provided by the State**
3 **Planned Social Services Block Grant (S.S.B.G.) through an Intergovernmental**
4 **Agreement between the Nation and the Arizona Department of Economic Security**
5 **(Contract No. DE091115001); and**

6 **WHEREAS, Amendment No. 2 to the Intergovernmental Agreement has been received to add**
7 **funding for the period of July 1, 2011 to June 30, 2012; and**

8 **WHEREAS, Amendment No. 2 sets the contract reimbursement ceiling for the grant funding at**
9 **\$120,644.00 and the Legislative Council has approved the Title XX Block Grant Budget**
10 **for \$120,644.00 in Resolution No. 11-252; and**

11 **WHEREAS, Amendment No. 2 to the Intergovernmental Agreement has been reviewed by the**
12 **Human Resources Development and Domestic Affairs Committees which recommend**
13 **approval by the Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **approve and authorizes Amendment No. 2 to the Nation's Intergovernmental**
16 **Agreement with the Arizona Department of Economic Security regarding the Planned**
17 **Social Services Title XX Block Grant substantially in the form attached hereto.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes and**
19 **directs the Chairperson to execute Amendment No. 2, provided that any amendments**
20 **affecting the contract amount shall be submitted for further prior approval by the**
21 **Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
23 **of SEPTEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (f) and 1 (l) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**


