

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Tohono O'odham Enrollment Resolution No. 11-074)**

**RESOLUTION NO. 11-461**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**  
2 **ordinances for governing the enrollment and adoption of members and the**  
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**  
4 **Article VI Section 1(h); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**  
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**  
7 **adoption; and**

8 **WHEREAS, on 03/07/2011 the Legislative Council pursuant to Resolution No. 11-074, approved**  
9 **Mario O. Coronado IV Roll No. 3677-B-00, Cesar M. Coronado Roll No. 3678-B-00 for**  
10 **membership in the Tohono O'odham Nation; and**

11 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**  
12 **and family tree, Mario O. Coronado IV listed with Roll No. 3677-B-00 and Cesar M.**  
13 **Coronado Roll No. 3678-B-00 were given the same numbers assigned to another**  
14 **member (Vianna L. Portugal-Grijalva and Tiana L. Hines pursuant to Resolution No.**  
15 **01-543 and 01-004); and**

16 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a number**  
17 **has been assigned to an application it shall not be changed; and**

18 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**  
19 **Legislative Council shall cause the membership roll be kept current.**

20 **NOW, THEREFORE, BE IT RESOLVED THAT:**

21 **1. The Tohono O'odham Legislative Council approves an amendment of Resolution**  
22 **No. 11-074 as follows:**

23 **Vianna L. Portugal-Grijalva, shall retain 3677-B-00, and Tiana L. Hines, shall retain**  
24 **3678-B-00. The Roll No. Listed for Mario O. Coronado IV be changed to 4571-B-00**  
25 **and Cesar M. Coronado be changed to 4572-B-00 to reflect the number originally**  
26 **assigned to the application of Mario O. Coronado IV and Cesar M. Coronado, which**  
27 **was approved by this Council pursuant to Resolution No. 11-074 on 03/07/2011.**

28 **2. The Enrollment Committee shall make the necessary changes in the records of the**  
29 **Enrollment Office to incorporate the stated amendment.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
31 **of OCTOBER 2011 at a meeting at which a quorum was present with a vote of 2,553.9 FOR; -0-**  
32 **AGAINST; 226.7 [04] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
33 **by Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the**  
34 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat. 984).**
