

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amend Enrollment Resolution No. 10-070)

RESOLUTION NO. 11-462

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(h); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on April 13, 2009 the Legislative Council pursuant to Resolution No. 09-167, approved**
9 **Jakyla R. Antone Roll No. 2456-P-09 for membership in the Tohono O'odham Nation;**
10 **and**

11 **WHEREAS, on March 08, 2010 the Legislative Council pursuant to Resolution No. 10-070 approved**
12 **Jakyla R. Antone Roll No. 2501-P-09 for membership in the Tohono O'odham Nation;**
13 **and**

14 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
15 **and family tree, Jakyla R. Antone listed with Roll No. 2456-P-09 and 2501-P-09 is the**
16 **same individual; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a number**
18 **has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 22 **1. The Tohono O'odham Legislative Council amends Resolution No. 10-070 as follows:**
23 **Jakyla R. Antone shall retain Roll No. 2456-P-09 to reflect the number originally**
24 **assigned to the application of Jakyla R. Antone on April 13, 2009 which was**
25 **approved by this Council pursuant to Resolution No. 09-167 and amend Resolution**
26 **No. 10-070 that the name Jakyla R. Antone Roll No. 2501-P-09 shall be removed.**
- 27 **2. The Enrollment Committee shall make the necessary changes in the records of the**
28 **Enrollment Office to incorporate the stated amendment.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
30 **of OCTOBER 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
31 **AGAINST; [03] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
35 **Stat. 984).**
