

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Amend Enrollment Resolution No. 10-257)**

RESOLUTION NO. 11-463

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(h); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on July 12, 2010 the Legislative Council pursuant to Resolution No. 10-257, approved**
9 **Lethycia N. Monte Roll No. 2535-P-10 for membership in the Tohono O'odham Nation;**
10 **and**

11 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
12 **and family tree, Lethycia N. Monte listed with Roll No. 2535-P-10 was given the same**
13 **number assigned to another member (Frank E. Sandoval pursuant to Resolution No.**
14 **10-337); and**

15 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a number**
16 **has been assigned to an application it shall not be changed; and**


17 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
18 **Legislative Council shall cause the membership roll be kept current.**

19 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 20 **1. The Tohono O'odham Legislative Council approves a modification of Resolution**
21 **No. 10-257 as follows:**
22 **Frank E. Sandoval shall retain Roll No. 2535-P-10. The Roll No. listed for Lethycia**
23 **N. Monte be changed to 2534-P-10 to reflect the number originally assigned to the**
24 **application of Lethycia N. Monte July 12, 2010 which was approved by this Council**
25 **pursuant to Resolution No. 10-257.**
26 **2. The Enrollment Committee shall make the necessary changes in the records of the**
27 **Enrollment Office to incorporate the stated amendment.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
29 **of OCTOBER 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
30 **AGAINST; [02] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**




