2 **issues pertaining to the Nation; and**

3 **WHEREAS, the Tohono O'odham Nation Legislative Council did pass Resolutions approving**
4 **additional apportionments of gaming revenues to the Nation's eleven Districts in the**
5 **amounts of:**

10 **WHEREAS, the Tohono O'odham Legislative Council also passed Resolution No. 11-434**
11 ***"Approving the Gu Achi District's Fiscal Year 2012 Budget of \$1,660,936.79"*; and**

12 **WHEREAS, the Gu Achi District received a statement of Gaming funds from the Tohono O'odham**
13 **Nation's Office of the Treasurer for earned interest funds in the amount of**
14 **\$22,943.57 to the District; and**

15 **WHEREAS, at a regularly scheduled meeting, the Gu Achi District Council approved a budget for**
16 **the amount of \$22,943.57 attached hereto for the District's Administration and**
17 **operational and direct services to meet the needs of the District; and**

18 **WHEREAS, the Gu Achi District Fiscal Year 2012 budget from the interest funds was presented,**
19 **reviewed and recommended for approval by the Tohono O'odham Legislative**
20 **Council's Budget and Finance Committee; and**

21 **WHEREAS, the District's budget of the \$22,943.57 will be administered as a separate budget**
22 **from the District's budget of the \$1,660,936.79 for fiscal year 2012.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council does**
24 **hereby approve the Gu Achi District's Fiscal Year 2012 Budget from the Interest**
25 **Funds in the amount of \$22,943.57 as attached hereto.**

26 **BE IT FINALLY RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
27 **Year 2012 budget in accordance with protocols set forth by this Council. Any**
28 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal**
29 **Year 2012 budget shall be approved by the Tohono O'odham Legislative Council.**




