

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract for FY2012 with the Law Firm of Kilpatrick  
Townsend & Stockton LLP)**

RESOLUTION NO. 11-480

1 WHEREAS, the Office of Attorney General continues to require the legal services of Kilpatrick  
2 Townsend & Stockton LLP in litigating the Nation's claims against the United States  
3 for trust assets mismanagement; and

4 WHEREAS, the Attorney General has recommended a budget of \$150,000.00 for this purpose in  
5 fiscal year 2012, for the period from October 1, 2011 to September 30, 2012; and

6 WHEREAS, the attorney contract will be funded from the budget of the Office of Attorney  
7 General, account number 01-1031-810; and


8 WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the  
9 attorney contract and recommend approval by the Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:

- 11 (1) Approves the attorney contract with the Kilpatrick Townsend & Stockton LLP law  
12 firm in the amount of \$150,000.00 for fiscal year 2012, for the period from  
13 October 1, 2011 to September 30, 2012, substantially in the form attached hereto.  
14 (2) The attorney contract will be funded from the operating budget of the Office of  
15 Attorney General, account number 01-1031-810.  
16 (3) Authorizes the Chairperson of the Nation to execute the contract and the  
17 attached Fee Agreement.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day  
19 of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
20 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
21 Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
22 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
24 Stat. 984).


