RESOLUTION NO. 11-483

1 **WHEREAS, the Office of Attorney General requires the legal services of the Wilmer Cutler**
2 **Pickering Hale and Dorr, LLP ("Wilmer Hale") law firm to represent the Tohono**
3 **O'odham Nation in matters relating to the West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract for fiscal year 2012 for**
5 **the period from October 1, 2011 to September 30, 2012; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the FY 2012 Economic**
7 **Development Budget; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this**
9 **attorney contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**
12 **the Wilmer Hale law firm for FY2012, for the period from October 1, 2011 to**
13 **September 30, 2012, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract will come from the FY 2012 Economic**
15 **Development Budget.**
- 16 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
19 **of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
