(Setting October 21, 2011 Special Session for the Tohono O'odham Ki:Ki Association
to Present Its Annual Performance Report)**

LEGISLATIVE ORDER NO. 11-490

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**


8 **WHEREAS, under the TOKA Ordinance, the Tohono O'odham Ki:Ki Association is required to**
9 **present its annual Performance Report to the Legislative Council before submitting**
10 **it to the Southwest Office of Native American Programs (TOKA Ordinance, Article IX,**
11 **2.v.); and**

12 **WHEREAS, the Legislative Council Housing Committee has requested a special session on October**
13 **21, 2011 for the Tohono O'odham Ki:Ki Association to present its annual Performance**
14 **Report.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
16 **special session for October 21, 2011 for the Tohono O'odham Ki:Ki Association to**
17 **present its annual Performance Report.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH day of**
19 **OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
