1 **WHEREAS, the Child Welfare Division, Phase Two Tribal Budget Account No. 01-1443 was**  
2 **approved by the Tohono O'odham Legislative Council by Resolution No. 11-320 in the**  
3 **amount of \$1,286,755.00; and**

4 **WHEREAS, the Child Welfare Phase Two budget amendment #1 is to decrease line item 710**  
5 **Utilities, line item 721 Supplies Other and line item 751 Lease/Rental; and**

6 **WHEREAS, the amendment will establish new line items for 770 RM Equipment, 812 Public**  
7 **Relations, 850 Food and 856 Client Support that have been identified as needed for**  
8 **operational expense; and**

9 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
10 **of the Legislative Council have reviewed this budget and recommend its approval**  
11 **and adoption.**


12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **budget amendment #1 to the Child Welfare Division FY 2012 account 01-1443 to:**

- 14 **1. Decrease line items 710 Utilities, 721 Supplies-Other and 751 Lease/Rentals.**
- 15 **2. Establishes new line items #770 RM Equipment, #812 Public Relations, #850 Food**  
16 **and #856 Client Support.**
- 17 **3. Approves the budget attached hereto.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
19 **Chairperson and any designated official to expend and administer the budget, as**  
20 **attached, provided that any amendments affecting the funds or funding levels of the**  
21 **budget shall be submitted for further prior approval by the Tohono O'odham**  
22 **Legislative council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
24 **of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
26 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**
