**RESOLUTION NO. 11-499**

1 **WHEREAS, the TERO Commission requires the legal services of Jackson Law Firm, P.L.L.C. to**  
2 **represent the TERO Commission in matters relating to the activities of the TERO**  
3 **Commission; and**

4 **WHEREAS, the TERO Commission has recommended a budget in the amount of \$50,600.00 for**  
5 **the fiscal year 2012 for the period of October 1, 2011 to September 30, 2012; and**

6 **WHEREAS, the funding of this Attorney Contract will come from the TERO Commission 2012**  
7 **Budget; and**


8 **WHEREAS, the Domestic Affairs and Budget and Finance Committee have reviewed this attorney**  
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**  
12 **Jackson Law Firm P.L.L.C. in the amount of \$50,600.00 for 2012, for the period**  
13 **from October 1, 2011 to September 30, 2012, substantially in the form attached**  
14 **hereto.**
- 15 **2. Funding for the Attorney Contract will come from the FY 2012 TERO Commission**  
16 **Budget.**
- 17 **3. The Chairperson of the Tohono O'odham Nation is authorized and directed to**  
18 **execute the Attorney Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
20 **of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
22 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
