

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY 2012 Budget)

RESOLUTION NO. 11-500

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to authority of the Tohono**
2 **O'odham Constitution has exclusive powers over the management of Nation's funds**
3 **and to appropriate these funds for the benefit of the Nation and its members; and**

4 **WHEREAS, annually, funds from gaming revenues are apportioned to each district for**
5 **budgetary purposes and on July 19, 2011 the Tohono O'odham Legislative Council**
6 **approved equal distribution of Gaming Revenues including a supplemental Gaming**
7 **Revenues totally \$1,660,996.79 and on 10 October 2011 approved to distribute the FY**
8 **2012 Mining Royalties to each district totaling \$124,666.96; and**

9 **WHEREAS, the San Lucy District Council met with the district's program managers and**
10 **supervisor in preparation of the new fiscal year budget, and with the community**
11 **members to discuss the FY 2012 budget; and**

12 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance committee have**
13 **reviewed the San Lucy District FY 2012 budget and agreed to forward the budget to**
14 **the legislative council for consideration.**

15 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves the**
16 **San Lucy District FY 2012 Budget in the amount of \$2,668,954.48, and said budget**
17 **approval shall be retro-active to October 1, 2011 and end September 30, 2012.**

18 **BE IT FURTHER RESOLVED the Tohono O'odham Legislative Council hereby appropriates**
19 **\$1,660,996.79 from Gaming Revenues (that includes \$500,081.45 from gaming saving**
20 **distributed as a supplemental amount); mining royalties of \$124,669.71 (including**
21 **\$2.75 interest from prior years); interest of \$762.84 from various San Lucy District**
22 **Savings Accounts; and \$882,830.00 from P.L. 99-503; to fund the FY 2012 San Lucy**
23 **District Budget.**

24 **BE IT FINALLY RESOLVED that bi-weekly disbursements of \$882,830.00 from P.L. 99-503 funds are**
25 **wire transferred to the San Lucy District General Account National Bank of Arizona**
26 **- Gila Bend Branch.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
28 **of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,658.15 FOR; 122.45**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
30 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
