1 **WHEREAS, the Gu-Vo District presented to the Tohono O'odham Legislative Council the**
2 **District's FY' 2012 Budgets for the fiscal year; and**

3 **WHEREAS, the Gu-Vo District was allocated Gaming Revenue in the amount of \$1,660,996.79;**

5 **WHEREAS, Gu-Vo District Governing Council at a meeting held on October 19, 2011 with a**
6 **quorum present, did review and approve the District FY' 2012 Budgets in the total**
7 **amount of \$2,023,054.43 per attached resolution; and**

8 **WHEREAS, Pursuant to Resolution GV-11-223 "Approving Gu-Vo District Administration Carry**
9 **Over of FY'2006 (\$103,231.31), Gu-Vo Community Carry Over of FY'2000 (\$40,000.00),**
10 **FY'2010 (\$29,050.50), Ali Chugk Community Carry Over of FY'1999 (\$24,337.95),**
11 **FY'2000 (\$25,496.78), FY'2005 (\$17,760.00), FY'2010 (\$35,181.10), and Pia-Oik**



BE IT FURTHER RESOLVED Pursuant to Resolution GV-11-223 "Approving Gu-Vo District Administration Carry Over of FY'2006 (\$103,231.31), Gu-Vo Community Carry Over of FY'2000 (\$40,000.00), FY'2010 (\$29,050.50), Ali Chugk Community Carry Over of FY'1999(\$24,337.95), FY'2000 (\$25,496.78), FY'2005(\$17,760.00), FY'2010(\$35,181.10), and Pia-Oik Community Carry Over of FY'2009(\$22,740.68), FY'2010(\$64,259.32) into Fiscal Year 2012 Budget, the total amount of \$362,057.64.

BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its Fiscal Year 2012 Budget according to the Tohono O'odham Nation's process, but any amendments affecting the funds or funding levels shall be approved by the Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day of OCTOBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




