

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for 401(K) Matters with Yoder & Langford, P.C.
for FY2012)

RESOLUTION NO. 11-516

1 **WHEREAS, the Tohono O'odham Nation has for several years contracted with the law firm of**
2 **Yoder & Langford, P.C. for legal services related to the 401(k) Plan of the Nation to**
3 **assist the 401(k) Trustees and the Human Resources Office; and**

4 **WHEREAS, the Attorney Contract for 401(K) is under the oversight of the Attorney General, but is**
5 **paid for out of the 401(K) budget of the Human Resources Office; and**

6 **WHEREAS, the last such Attorney Contract expired on September 30, 2011; and**

7 **WHEREAS, it is in the best interest of the Nation to continue representation by the Attorney; and**

8 **WHEREAS, the Human Resources Officer and the Attorney General recommend an Attorney**
9 **Contract with the Attorney in the amount of \$15,000 for the period of October 1, 2011**
10 **through September 30, 2012; and**

11 **WHEREAS, the 401(K) Trustee budget has sufficient funds for the contract amount; and**

12 **WHEREAS, the Human Resources Development Committee, the Domestic Affairs Committee and**
13 **the Budget and Finance Committee recommend approval by the Legislative Council**
14 **of the Attorney Contract.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council approves the Attorney Contract for 401(K)**
17 **matters with the law firm of Yoder & Langford, P.C., in the amount of \$15,000 for**
18 **the period of October 1, 2011 through September 30, 2012, substantially in the**
19 **form attached hereto.**
- 20 **2. Funding for the Attorney Contract shall be provided from the 401(K) Trustee**
21 **budget.**
- 22 **3. The Chairman of the Nation or any authorized official is directed to execute the**
23 **Attorney Contract.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th Day**
25 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,553.90 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 226.70[04] ABSENT, pursuant to the powers vested in the Council**
27 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**






