

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Clark Law Firm)

RESOLUTION NO. 11-517

1 **WHEREAS, it is advisable that the Human Resources Office has available independent legal**
2 **representation for employment issues in which the Office of Attorney General is**
3 **unable to provide legal advice due to conflicts of interest; and**

4 **WHEREAS, the Human Resource Office recommends an Attorney Contract with The Clark Law**
5 **Firm to provide legal representation to the Human Resource Office for the foregoing**
6 **purposes; and**

7 **WHEREAS, the proposed Attorney Contract is in the amount of \$20,000.00 for the period from**
8 **October 01, 2011 through September 30, 2012; and**

9 **WHEREAS, the operation budget for the Human Resource Office (account No. 01-1005-810/7355)**
10 **for fiscal year 2012 includes sufficient funds for the Attorney Contract; and**


11 **WHEREAS, the Domestic Affairs Committee, Human Resource Development Committee and the**
12 **Budget and Finance Committee recommends approval by the Legislative Council of**
13 **an attorney contract.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an attorney contract**
16 **with the Clark Law Firm in the amount of \$20,000.00 for the Fiscal Year ending**
17 **September 30, 2012, and in the form attached hereto.**
- 18 **2. Funding for the Attorney Contract in Fiscal year 2012 shall be provided under the**
19 **operating budget of the Human Resources Office (Account No. 01-1005-810/7355).**
- 20 **3. The Chairman of the Nation or any designated official is authorized and directed**
21 **to execute the Attorney Contract.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th Day**
23 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,594.30 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 186.30[07] ABSENT, pursuant to the powers vested in the Council**
25 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
