

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District's Carry Over Budget from the Fiscal Year 2010
Apportionment of Mining Royalties in the amount of \$22,378.72)**

RESOLUTION NO. 11-520

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on November 15, 2011 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 09-583, "Approving FY**
4 **2010 Gu Achi District's Budget from the Apportionment of Mining Royalties" in the**
5 **amount of \$127,189.58; and**

6 **WHEREAS, funds were spent from the FY 2010 District Mining Royalties budget with a remaining**
7 **balance of unspent funds in the amount of \$22,378.72; and**


8 **WHEREAS, on November 4, 2011, the Gu Achi District Council approved a budget in the amount**
9 **of \$22,378.72 to fund the expense of conducting a financial audit for the Gu Achi**
10 **Trading Post.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
12 **approve the Gu Achi District's Carry Over Budget from the Fiscal Year 2010**
13 **Apportionment of Mining Royalties in the amount of \$22,378.72.**

14 **BE IT FINALLY RESOLVED that the Gu Achi District Council reserves the right to modify its Fiscal**
15 **Year budgets according to the Tohono O'odham Nation's process, but any**
16 **amendments affecting the funds or funding levels shall be approved by the Tohono**
17 **O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15th Day**
19 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
22 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
