

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 2 to the Intergovernmental Agreement with the
Arizona Department of Economic Security regarding Workforce Investment
Act funding for the One Stop Division)**

RESOLUTION NO. 11-522

1 **WHEREAS, the Nation and the Arizona Department of Economic Security executed an**
2 **intergovernmental agreement (IGA) under which the Nation receives funds for specific**
3 **Workforce Investment Act (WIA) employment and training programs operated by the**
4 **Education Department's One Stop Division (Contract No. DE111026-001); and**

5 **WHEREAS, Amendment No. 2 has been received to, among other things, extend the term of the IGA**
6 **from June 30, 2013 to August 31, 2015, and incorporates FY12 funding to set the new**
7 **reimbursement ceilings for grant funding, and to add certain provisions required by**
8 **the U.S. Department of Labor; and**

9 **WHEREAS, pursuant to the IGA, the Arizona Department of Economic Security has allocated funds**
10 **to the Nation for FY2012 in the amount of \$243,436.00 for the period beginning April**
11 **1, 2010 to August 31, 2015; and**

12 **WHEREAS, the One Stop Division program FY12 budgets will be amended to reflect the actual**
13 **award.**

14 **WHEREAS, the Domestic Affairs Committee, Human Resources Development Committee and the**
15 **Budget & Finance Committee have reviewed the One Stop Division Amendment No. 2**
16 **and recommends Legislative Council approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
18 **and authorizes Amendment No. 2 to the Intergovernmental Agreement between the**
19 **Nation and the Arizona Department of Economic Security substantially in the forms**
20 **attached hereto, and authorizes the Chairman of the Tohono O'odham Nation to**
21 **execute it.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15th Day**
23 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (d)(3) (f) and (l) of Article VI of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**






