RESOLUTION NO. 11-525

1 **WHEREAS, by Resolution No. 11-326, the Tohono O'odham Legislative Council approved the**
2 **Department of Health and Human Services FY 2012 BIA ICWA Family Preservation**
3 **budget in the amount of \$199,222.49; and**

4 **WHEREAS, the Department of Health and Human services has prepared the attached FY 2012 BIA**
5 **ICWA Family Preservation 10-1312 budget amendment #1, which incorporates**
6 **amounts in new line item RM vehicle in the amount of \$2,138.00 and increases the**
7 **indirect cost from \$28,684.49 to \$32,095.25 and decreasing 710 Utilities, 711**
8 **Communications and 721 Supplies Other for a budget total in the amount of**
9 **\$202,633.25; and**

10 **WHEREAS, the Executive Office, the Health and Human Service Oversight Committee and the**
11 **Budget & Finance Committee has reviewed and approved this budget amendment.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **the budget amendment #1, in the total amount of \$202,633.25 per attached FY 2012 BIA**
14 **ICWA Family Preservation 10-1312, effective October 1, 2011 through September 30,**
15 **2012.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget, as**
18 **attached, provided that any amendments affecting the funds or funding level shall be**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th Day**
21 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(3) and 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted**
24 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
