

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving 2nd Year of Contract (No. FA4887-10-R-0042) with the United States Air
Force-Luke Air Force Base to conduct a study of Traditional Cultural Places on the
Barry M. Goldwater Range, near Gila Bend, Arizona and Approving the FY 2012 Budget)

RESOLUTION NO. 11-529

1 **WHEREAS, the Tohono O'odham Nation ("Nation") recognizes the need to protect, preserve and**
2 **manage cultural resources and traditional cultural places on its traditional-use lands;**
3 **and**

4 **WHEREAS, the Barry M. Goldwater Range, managed by the U.S. Air Force ("USAF") located west of**
5 **the Nation, consists entirely of the traditional-use lands of the Nation; and**

6 **WHEREAS, the USAF has agreed to fund the Nation to undertake and complete a two year study of**
7 **traditional cultural places located on the Goldwater Range in the amount of \$249,730**
8 **(see attached budget); and**

9 **WHEREAS, the final report from this study will be used as a management tool for the USAF to**
10 **better protect and preserve traditional cultural places on the Goldwater Range; and**

11 **WHEREAS, the final report will provide important information on the history and culture of the**
12 **Nation; and**

13 **WHEREAS, the Legislative Council approved Contract FA4887-10-R-0042 with the United States Air**
14 **Force by Resolution No. 10-472 on December 17, 2010; and**

15 **WHEREAS, work has commenced on the project through FY 2011 and there is a need to continue**
16 **this project into FY 2012; and**

17 **WHEREAS, there is an account balance of \$216,219.79 that needs to be carried over into FY 2012.**

18 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 19 **1. The Legislative Council does hereby approve the second year of Contract No.**
20 **FA4887-10-R-0042 in substantially the form attached hereto, with USAF. In the**
21 **amount of \$216,219.79 as attached hereto for FY 2012.**
- 22 **2. Project personnel shall consist of: Principal Investigator (Consultant), Research**
23 **Assistant (Consultant) for the GPS mapping portion of the project, Project Director**
24 **from the Tohono O'odham Nation (Consultant) and Research Assistant from the**
25 **Tohono O'odham Nation (Consultant).**
- 26 **3. Carryover of funds provided by the USAF for the Goldwater Range Traditional**
27 **Cultural Places Study shall be carried over from FY 2012 to FY 2013, with an**
28 **approved budget.**
