

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Transfer of Funds from Desert Diamond Savings to Establish  
Accounts at Wells Fargo Minors Trust for 146 Eligible Minor Members for the  
Fourth Per Capita Distribution)**

**RESOLUTION NO. 11-532**

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" (Initiative), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (Legislative Council**  
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Fourth Per Capita Revenue Allocation Plan ("Revenue Allocation Plan"), which**  
10 **authorizes the fourth per capita payment to all eligible Tohono O'odham members,**  
11 **was adopted by the Tohono O'odham Legislative Council, Resolution No. 09-164; and**

12 **WHEREAS, On June 15, 2009, the Department of the Interior approved the Revenue Allocation**  
13 **Plan; and**

14 **WHEREAS, in accordance with the Revenue Allocation Plan, the Tohono O'odham Membership**  
15 **Services presented the Master List for eligible Tohono O'odham Minor Members for**  
16 **the Fourth Per Capita Distribution and established the number of eligible minor**  
17 **members at 8,664 members pursuant to Resolution No. 09-429; and**

18 **WHEREAS, the Tohono O'odham Legislative Council has established the number of eligible minor**  
19 **members at 8,664. pursuant to Resolution No. 09-429, "Approving the Master List for**  
20 **the Fourth Per Capita Distribution for Eligible Tohono O'odham Minor members; and**

21 **WHEREAS, the Office of the Treasurer performed a review of the minors trust accounts and found**  
22 **146 minors requiring funding to establish accounts under the Revenue Allocation**  
23 **Plan's Fourth Per Capita Distribution; and**

24 **WHEREAS, the Enrollment Program verified the eligibility of the list of 146 minors members; and**

25 **WHEREAS, the Treasurer recommends transferring \$304,408.86 from the Desert Diamond**  
26 **Savings Investment Account to Wells Fargo Minors Trust to establish accounts for the**  
27 **list of 146 minor members contingent upon further verification and certification by**  
28 **the Tohono O'odham Legislative Council when the minors turn 18 years of age; the**



1 Legislative Rules and Budget and Finance Committees have reviewed and supports the  
2 Treasurer's recommendation.

3 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the  
4 transfer of \$304,408.86 from the Desert Diamond Savings Investment Account to Wells  
5 Fargo Minors Trust to establish accounts for the list of 146 eligible minor members for  
6 the fourth per capita distribution pursuant to the Revenue Allocation Plan.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>th</sup> Day  
8 of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
9 AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by  
10 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
11 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
13 18, 1934 (48 Stat. 984).


