1 **WHEREAS, the Planning and Economic Development Department's Roads Program was funded**
2 **by Discretionary Funds as part of the BIA P.L. 93-638 Master Contract as approved by**
3 **Tohono O'odham Legislative Council Resolution #10-331; and**

4 **WHEREAS, the Planning and Economic Development Department provides day to day**
5 **management of the Department's Roads Program and presents to the Tohono**
6 **O'odham Legislative Council, for review and approval, the FY 2012 Roads**
7 **Discretionary Funds Program budget for project IRR 102; and**

8 **WHEREAS, the Planning and Economic Development Department has developed the attached**
9 **budget for the FY 2012 Roads Discretionary Funds Program budget for project IRR 102**
10 **in the amount of \$765,129.22; and**

11 **WHEREAS, FY-2012 Roads Discretionary Funds Program Budget for project IRR 102 has been**
12 **reviewed by the Commerce, the Agricultural & Natural Resources and the Budget &**
13 **Finance Committees and they recommend its approval and adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **the FY-2012 Roads Discretionary Funds Program Budget for project IRR 102 in the**
16 **amount of \$765,129.22 in accordance with the budget attached.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget, as**
19 **attached, provided that any amendments affecting the funds or funding levels of the**
20 **budget shall be submitted for further prior approval by the Tohono O'odham**
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16th Day**
23 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (d)(3) and (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
26 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
