(Authorization to expend \$62,608.70 in FY-2012 from I.H.S. ARRA Requisition
No. 1230, Order No. Four (4))

RESOLUTION NO. 11-536

1 **WHEREAS, the Indian Health Service has identified additional funds that remain for ARRA dump**
2 **closure work in the amount of \$62,608.70; and**

3 **WHEREAS, the Solid Waste Regulatory Office (SWRO), the Solid Waste Management Program**
4 **(SWMP) and the Indian Health Services (I.H.S.) have met and identified, inspected, and**
5 **confirmed that eight small dump sites need to be cleaned up and closed; and**

6 **WHEREAS, the eight small dump sites are located in Pia Oik - two sites, Gu Vo - two sites, Santa**
7 **Rosa - two sites, and Chui Chu - two sites; and**

8 **WHEREAS, the notice to proceed letter from I.H.S. is attached listing dump sites to be closed by**
9 **the completion date of September 30, 2012 with requisition number 1230, and change**
10 **order #4; and**


11 **WHEREAS, the SWMP FY-2012 ARRA - I.H.S. Budget 200-12-3570 of \$62,608.70 has been reviewed**
12 **by the Legislative Agriculture and Natural Resources Committee and the Legislative**
13 **Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**
15 **expenditure of \$62,608.70 for the SWMP FY2012 ARRA - I.H.S. budget attached hereto.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level is**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16th Day**
21 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,564.80 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 215.80[06] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
