

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and authorizing budget modification # 1 of KOHN FM' s FY 2012
Corporation for Public Broadcasting Community Service Grant; Creating and
funding the position of Programming Coordinator)**

RESOLUTION NO. 11-537

1 **WHEREAS, by Resolution No. 11-342, the Tohono O'odham Legislative Council (Council) approved**
2 **and authorized KOHN FM's Corporation for Public Broadcasting Community Service**
3 **Grant (CPB CSG) for fiscal year 2012; and**

4 **WHEREAS, KOHN management (Management) established a career ladder to encourage**
5 **professional development of staff to the level of a Program Director; and**

6 **WHEREAS, a staff member has attained the necessary qualifications and experience to be**
7 **considered for the position of Programming Coordinator which has been created but**
8 **has not yet been funded; and**

9 **WHEREAS, Management has prepared the attached budget modification to defund the current**
10 **Production Technician's salary in order to provide for the funding of the proposed**
11 **Programming Coordinator's position, with additional funds as required to be re-**
12 **allocated from program operations; and**

13 **WHEREAS, Management requests that the funding of the Programming Coordinator's position**
14 **be retroactive to October 1, 2011 and effective as of that date.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
16 **approve and authorize budget modification # 1 of KOHN FM's FY 2012 Corporation for**
17 **Public Broadcasting Community Service Grant, creating and funding the position of**
18 **Programming Coordinator.**

19 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the funding for the**
20 **Programming Coordinator be retroactive to October 1, 2011 and for it to be effective**
21 **as of that date.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
