

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2012 Legislative Branch Budget Amendment No. 1 Adding one-time
surplus funding of \$101,727.50)**

RESOLUTION NO. 11-538

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Branch FY 2012 budget was approved by Resolution No. 11-321; and**

7 **WHEREAS, the Legislative Branch administration has prepared and submitted for review and**
8 **approval its FY 2012 Budget Amendment No. 1 in the amount of \$101,727.50 for**
9 **purchase of replacement vehicles for the Legislative Branch; and**

10 **WHEREAS, FY 2012 General Revenue Surplus funds have been identified as the funding source for**
11 **purchasing the replacement vehicles; and**

12 **WHEREAS, the FY 2012 Legislative Branch Budget Amendment No. 1 has been reviewed by the**
13 **Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **a one-time appropriation of \$101,727.50 in FY 2012 General Revenue Surplus funds in**
16 **accordance with the attached FY 2012 Legislative Branch Budget Amendment No. 1,**
17 **which is hereby approved.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation Legislative Council Chairman and Vice-Chairman are authorized to administer**
20 **the attached budget, provided however, that any amendments affecting these funds**
21 **or funding levels budgeted shall be submitted for prior approval by the Tohono**
22 **O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16th Day**
24 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


