1 **WHEREAS, the Tohono O'odham Nation Department of Public Safety (TON DPS) has been awarded**
2 **the Department of Justice (DOJ) Office of Justice (OJP) Programs Office of Juvenile**
3 **Justice and Delinquency Prevention (OJJDP) Youth Mentoring Program Grant in the**
4 **amount of \$499,997.00 under grant number 2011-TY-FX-0010; and**

5 **WHEREAS, this grant is a three year funded grant starting October 1, 2011 thru September 30,**
6 **2014; and**

7 **WHEREAS, this grant has awarded funding for two new position a Youth Mentor Program**
8 **Manager and an Administrative Assistant to be funded for all three years; and**

9 **WHEREAS, this grant allows for Operational Cost and a budget was created with line items 655**
10 **Lodging, 660 Travel Expense, 710 Utilities, 711 Communication Expense, 712 Gas, Oil**
11 **& Coolants, 720 Supplies – Office, 721 Supplies – Other, 810 Professional Services, and**
12 **812 Public Relations for total cost including personnel in the amount of \$159,729.30**
13 **for the first year of the grant; and**

14 **WHEREAS, Indirect Cost is applicable for this project and is budgeted at the approved rate of**
15 **18.82%; and**

16 **WHEREAS, the attached DOJ OJP OJJDP Youth Mentoring Program Grant and budget for FY 2012**
17 **in the amount of \$159,729.73 has been reviewed by the budget office, Grants &**
18 **Contracts, Executive, Domestic Affairs and Budget & Finance which all recommend**
19 **acceptance and approval.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
21 **accepts the Department of Justice Office of Justice Programs Office of Juvenile Justice**
22 **and Delinquency Prevention Youth Mentoring Grant in the amount of \$499,997.00 for**
23 **a three year grant period of October 1, 2011 thru September 30, 2014 with a FY 2012**
24 **budget in the amount of \$159,729.73.**



11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**
