RESOLUTION NO. 11-542

1 **WHEREAS, the Tohono O'odham Nation Police (TONPD) Department Corrections Program applied**
2 **for and was awarded the Department of Justice Office of Justice Programs Bureau of**
3 **Justice Assistance Tohono O'odham Nation Resource Center Grant No. 2011-IP-BX-**
4 **0001 in the amount of \$350,004.00 for a three year grant from October 1, 2011 through**
5 **September 30, 2014; and**

6 **WHEREAS, the TONPD Corrections Program has created a FY 2012 first year budget in the amount**
7 **of \$122,400.07 that includes two new positions, for a Resource Center Program**
8 **Manager and Office Support Worker and Operational Cost; and**

9 **WHEREAS, Indirect Cost is applicable for this project and is budgeted at the approved rate of**
10 **18.82%; and**

11 **WHEREAS, this grant and budget has been reviewed by the Budget Office, Grants & Contracts,**
12 **Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of all**
13 **which recommend acceptance by the Tohono O'odham Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
15 **accepts the Department of Justice Office of Justice Programs Bureau of Justice**
16 **Assistance Tohono O'odham Nation Resource Center Grant No. 2011-IP-BX-0001 in the**
17 **amount of \$350,004.00 for a three year grant period of October 1, 2011 through**
18 **September 30, 2014.**

19 **BE IT FURTHER RESOLVED that the TOLC approves the FY 2012 budget that includes two new**
20 **positions for a Resource Center Program Manager and Office Support Worker along**
21 **with operational cost and Indirect Cost for a total FY 2012 budget amount of**
22 **\$122,400.07.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to execute award documents and to expend**
25 **and administer the budget as attached, provided that any Amendments affecting the**
26 **funds or funding level is submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**
