

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Removing Tohono O'odham Ki:Ki Association Board Directors Gloria Pancho,
Gloria Bracamonte, and Noreen Ignacio-Pablo)**

RESOLUTION NO. 11-558

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with all the legislative powers of the**
2 **Nation, and is specifically vested with the power to enact ordinances "to promote,**
3 **protect and provide for public health, peace, morals, education and general welfare**
4 **of the Tohono O'odham Nation and its members" (Constitution of the Tohono O'odham**
5 **Nation, Article V, Section 1; Article VI, Section 1 and Section 1(c)(2); and**
6 **WHEREAS, the Legislative Council established the Tohono O'odham Ki:Ki Association ("TOKA") as**
7 **a separate tribal entity in accordance with Article VI of the Constitution of the Tohono**
8 **O'odham Nation and pursuant to Legislative Council Ordinance No. 98-03, as amended**
9 **("TOKA Ordinance"), 18 T.O.C. Ch. 1, www.tolc-nsn.org/docs/Title18Ch1.pdf; and**
10 **WHEREAS, the TOKA Ordinance authorizes the Legislative Council to appoint five members to the**
11 **TOKA's Board of Directors and to remove the Board of Directors "either individually**
12 **or as a whole, by resolution of the Tohono O'odham Legislative Council, with or**
13 **without cause." (TOKA Ordinance, Article V, Section 3); and**
14 **WHEREAS, effective June 2, 2011 the Legislative Council by Resolution No. 11-211 suspended**
15 **Directors Gloria Pancho, Gloria Bracamonte, and Noreen Ignacio-Pablo from the**
16 **TOKA Board of Directors; and**
17 **WHEREAS, it is in the Nation's best interest to remove Directors Gloria Pancho, Gloria**
18 **Bracamonte, and Noreen Ignacio-Pablo from the TOKA Board of Directors.**
19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby removes**
20 **Directors Gloria Pancho, Gloria Bracamonte, and Noreen Ignacio-Pablo from the**
21 **TOKA Board of Directors.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
23 **of NOVEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,327.15 FOR; 453.45**
24 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 of Article V and Section 1 (c)(2) of Article VI of the Constitution of the Tohono O'odham**
26 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
28 **of the Act of June 18, 1934 (48 Stat. 984).**




