

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2012 with the Lenihan Law Firm)**

RESOLUTION NO. 11-563

1 **WHEREAS, the Office of Attorney General requires the legal services of the Lenihan Law Firm to**
2 **represent the Tohono O'odham Nation in matters relating to the acquisition of thirty-**
3 **nine (39) patented mining claims; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$20,000.00 for the period from**
5 **October 1, 2011 to September 30, 2012; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the Land Acquisition Fund; and**


7 **WHEREAS, the Agricultural and Natural Resources and Domestic Affairs and Budget and Finance**
8 **Committees have reviewed this attorney contract and recommend approval by the**
9 **Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**
12 **Lenihan Law Firm in the amount of \$20,000.00 for FY2012, for the period from**
13 **October 1, 2011 to September 30, 2012, substantially in the form attached hereto.**
- 14 **2. Funding for the Attorney Contract will come from the Land Acquisition Fund.**
- 15 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
16 **Contract.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
18 **of DECEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
19 **AGAINST; [02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 2(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
