(Approving FY 2012 Pisinemo District Administration Budget
Modification/Amendment #1 in the amount of \$21,183.98)

RESOLUTION NO. 11-564

1 **WHEREAS, the Pisinemo District Council at a regular meeting on November 22, 2011 reviewed a**
2 **proposed budget modification/amendment from the District Administration; and**

3 **WHEREAS, the budget modification/amendment #1 consisted of adding a 2.5% Cost of Living**
4 **Adjustment (COLA) to the District's Administration Budget under Salaries and Fringe**
5 **Benefits; and**

6 **WHEREAS, the modification/amendment involves a reduction in line item 772 R&M Building by**
7 **\$21,183.98; and**

8 **WHEREAS, the \$21,183.98 will cover salaries adjustments in the amount of \$16,170.98 as well as**
9 **fringe benefits in the amount \$5,013.00; and**

10 **WHEREAS, a recommendation was made for the 2.5% Cost of Living Adjustment (COLA) be**
11 **retroactive to October 1, 2011 in line with Fiscal Year 2012 budget cycle.**


12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the request from Pisinemo District Administration to modify/amend its FY**
14 **2012 Budget in the amount of \$21,183.98.**

15 **BE IT FURTHER RESOLVED that the approved 2.5% Cost of Living Adjustment (COLA) shall be**
16 **retroactive to October 1, 2011 in line with Fiscal Year 2012 budget cycle.**

17 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of this budget**
18 **shall be submitted to the Tohono O'odham Legislative Council for further prior**
19 **approval.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 2ND Day**
21 **of DECEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by**
24 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
