**(Approval of the Tohono O'odham Department of Health and Human Services, Management of Health, Public Health Preparedness and Response - Bio Terrorism (BT) Grant Award ADHS11-005790 FY 2012 Budget in the amount of \$ 61,709.95)**

**RESOLUTION NO. 11-575**

1 **WHEREAS, the Tohono O'odham Nation is concerned with the health, welfare and safety of its**  
2 **members who reside on or near the Tohono O'odham Nation Reservation, including**  
3 **the O'odham in Mexico; and**

4 **WHEREAS, Public Health Preparedness and Emergency Response for Bioterrorism is within the**  
5 **charter of the Tohono O'odham Nation Department of Health and Human Services,**  
6 **Management of Health; and**

7 **WHEREAS, the Tohono O'odham Nation entered into an Fixed Price Intergovernmental**  
8 **Agreement (IGA) ADHS11-005790, with the Arizona Department of Health Services**  
9 **(ADHS) for Public Health Preparedness and Response for Bioterrorism in the amount**  
10 **of \$80,000.00 with a project period of 09/01/10 - 08/31/15, requiring a 10% match per**  
11 **Center for Disease Control award stipulations; and**

12 **WHEREAS, Arizona Health Services has authorized the funds from 09/01/10 - 08/31/11 to be**  
13 **expended through 08/31/12, and Grants and Contracts has identified a carry forward**  
14 **balance of \$61,709.95; and**

15 **WHEREAS, the 10% match requirement per Center for Disease Control will be met by cost sharing**  
16 **the PHEP Coordinator salary with Community Health; and**

17 **WHEREAS, the budget has been reviewed by the Budget Office, Grants & Contract, Executive**  
18 **Office, Health Committee and Budget & Finance Committee of all which recommended**  
19 **for acceptance by the Legislative Council.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

21 **1. Approves the FY2012 Bio Terrorism carry forward budget in the amount of**  
22 **\$61,709.95 with project period of 09/01/10 - 08/31/12.**

23 **2. Authorizes the Nation to obligate and expend funds upon approval.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **Chairperson and any designated official to expend and administer the budget as**  
26 **attached, provided that any amendments affecting the funds or funding level shall be**  
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


