

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Nation Scholarship Fund FY2012 Budget
Amendment #1 – Account #001-12-2002-7675 in the amount of \$500,000.00)**

RESOLUTION NO. 11-576

1 **WHEREAS, the Tohono O'odham Nation established the Tohono O'odham Nation Scholarship**
2 **Fund program through resolution #95-224 to fund tribal members who wish to further**
3 **their education and develop their skills through tribal funds; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2012 Tohono O'odham**
5 **Nation Scholarship Fund budget in the amount of \$5,969,089.12 pursuant to**
6 **Legislative Council Resolution No. 11-320; and**

7 **WHEREAS, the FY 2012 Tohono O'odham Nation Scholarship Fund is hereby amended to increase**
8 **the base budget by \$500,000.00 bringing the total base budget to \$6,469,089.12; and**

9 **WHEREAS, the Tohono O'odham Nation Scholarship Fund will increase line item Scholarships &**
10 **Tuition; and**

11 **WHEREAS, the FY 2012 Tohono O'odham Nation Scholarship Fund Budget Amendment No. 1 has**
12 **been reviewed and approved by the Human Resource Development Committee and**
13 **the Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **appropriates \$500,000.00 from the surplus fund and approves the Tohono O'odham**
16 **Nation Scholarship Fund FY2012 Budget Amendment No. 1 from base budget amount**
17 **of \$5,969,089.12 to \$6,469,089.12 to reoccur every year, attached hereto.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairman or Vice-Chairman and any designated official to expend and administer the**
20 **budget as attached, provided that any amendment affecting the funding or funding**
21 **levels of the budget shall be submitted for approval by the Tohono O'odham**
22 **Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
24 **of DECEMBER, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


