

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2012 Sells District Economic Development Committee Budget for \$14,500.00)

RESOLUTION NO. 11-578

1 **WHEREAS, Sells District Council approved resolution #SD-65-10 on July 20, 2010 prohibiting**
2 **vendors from vending in the area located west of Tohono Plaza, the area of the Big**
3 **Tree located east across Main Street from the Sells Service Station and the open area**
4 **located north of Sells Service Station along the Sells Wash; and**

5 **WHEREAS, resolution SD-65-10 was enacted because of the disregard by the vendors in keeping**
6 **the area clean of trash, improperly disposing of grease and coals which have caused**
7 **fires; and**

8 **WHEREAS, the Sells District Economic Development Committee (EDC) is an oversight committee**
9 **that oversees the Districts businesses and was tasked with developing a Vendor Policy**
10 **in which a specific area is to be identified for vending; and**

11 **WHEREAS, the Economic Development Committee proposed a project to build ramada type**
12 **structures as Phase One of the project and in the future build upon those structures**
13 **in the area north of the Sells Service Station along the Sells Wash; and**

14 **WHEREAS, the Economic Development Committee has identified funds in the amount of**
15 **\$14,500.00 from the Morgan Stanley Smith Barney account titled Economic**
16 **Development to be utilized toward this project; and**

17 **WHEREAS, the Economic Development Committee has submitted the attached budget and it's**
18 **justification in the amount of \$14,500.00 which was approved by the Sells District**
19 **Council with Resolution SD-114-11.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approved the**
21 **FY2012 Sells District Economic Development Committee Budget in the amount of**
22 **\$14,500.00 from funding available in the Sells District account with Morgan Stanley**
23 **Smith Barney account titled Economic Development.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
25 **District Chairperson and any designated District official to expend and administer the**
26 **budget according to its justification as attached, provided that any**
27 **modifications/amendments affecting the funds or funding levels of the budget shall**
28 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**




