(Approval of carry forward funds for the US Department of Homeland Security, FEMA, FY2010 Tribal Homeland Security Grant Program (THSGP) #2010-SS-TO-0052 for \$1,652,545.26)

RESOLUTION NO. 11-582

- 1 **WHEREAS, the United States Department of Homeland Security, Federal Emergency Management**
2 **Agency (FEMA) has distributed grants states to fund for purchases that provide public**
3 **safety services within their respective jurisdictions; and**
- 4 **WHEREAS, eligible Indian tribes have been designated to receive direct funding from the DHS-**
5 **FEMA established from the 9-11 Recommendations Act; and**
- 6 **WHEREAS, the Tohono O'odham Nation has submitted an application in FY2010 to FEMA for direct**
7 **funding under the Tribal Homeland Security Grant Program; and**
- 8 **WHEREAS, the Tohono O'odham Nation was awarded a grant from the DHS - FEMA in the amount**
9 **of \$1,657,500.00 as part of the FY2010 Tribal Homeland Security Grant Program to help**
10 **strengthen the Nation against risks associated with potential terrorist attacks and**
11 **natural disasters; and**
- 12 **WHEREAS, the attached budget is for FY 2012 beginning October 1, 2011 through September 30,**
13 **2012 and is in the amount of \$1,652,545.26 for year 2 and is estimated and may be**
14 **adjusted at a later date if needed; and**
- 15 **WHEREAS, the grant guidance for this grant award only allows five (5) percent for indirect costs**
16 **to be charge to manage and administer the grant; and**
- 17 **WHEREAS, the FY2010 Tribal Homeland Security Grant Program Grant No. 2010-SS-TO-0052 carry**
18 **forward funds in the amount of \$1,652,545.26 has been reviewed by the Office of Grants**
19 **& Contracts, Executive Office, Domestic Affairs Committee and Budget & Finance**
20 **Committee, of which all recommend acceptance of the grant award by the Legislative**
21 **Council.**
- 22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **carry forward funds of the FY2010 THSGP Grant No. 2010-SS-TO-0052 in the amount of**
24 **\$1,652,545.26 on a reimbursement basis from the Tohono O'odham Nation General**
25 **Fund.**
- 26 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and authorizes**
27 **the Office of Emergency Management to expend funds from the 2010 THSGP in**
28 **accordance with the terms of the grant for the Budget period of 10/01/11 to 09/30/12.**
- 29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation's Officials to wit the Chairman, Vice-Chairwoman and any designated official**
31 **are authorized to negotiate and execute the grant, provided however, that any**
