

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Tohono O'odham Nation Department of Health and Human
Services Division of Senior Services Title III Budget Amendments No. 1)**

RESOLUTION NO. 18-010

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Health and Human Services ("DHHS") Division of
8 Senior Services Title III C-1 Congregate Budget; C-2 Home Delivered Meals
9 Budget; B-Transportation Budget; E-Caregiver Information and Referral Budget;
10 E-Caregiver Outreach Budget; Caregiver Training Budget; and LTC Ombudsman
11 Budget (collectively, the "Title III Budget") were approved by Resolution No. 17-
12 317; and

13 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2018
14 Division of Senior Services Title III Budget Amendments No. 1, which are
15 incorporated by this reference, and which reflect the actual FY 2018 fiscal awards
16 and adjust operational and/or personnel line items; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2018 DHHS Division of Senior Services Title III Budget
19 Amendments No. 1 and recommend their approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2018 DHHS Division of Senior Services Title III Budget Amendments No. 1 as
22 follows:

- 23 1. C-1 Congregate Budget decrease of \$20,080.00 from \$61,153.00 to \$41,073.00;
- 24 2. C-2 Home Delivered Meals Budget increase of \$2,719.00 from \$25,716.00 to
25 \$28,435.00;
- 26 3. B-Transportation Budget decrease of \$9,170.00 from \$33,020.00 to \$23,850.00;
- 27 4. E-Caregiver Information and Referral Budget decrease of \$1,000.00 from
28 \$4,000.00 to \$3,000.00;
- 29 5. E-Caregiver Outreach Budget decrease of \$4,205.00 from \$8,171.00 to
30 \$3,966.00;
- 31 6. Caregiver Training Budget decrease of \$4,884.00 from \$8,871.00 to \$3,987.00;
- 32 and
- 33 7. LTC Ombudsman Budget decrease of \$5,000.00 from \$10,000.00 to \$5,000.00.



1 **BE IT FURTHER RESOLVED** that the FY 2018 DHHS Division of Senior Services Title III Budget
2 Amendments No. 1 shall be funded by the Nation's General Fund pending
3 reimbursement from the Inter-Tribal Council of Arizona for the continuation of
4 these grants.

5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
6 Nation chairperson or any designated official is authorized to administer and
7 expend the FY 2018 DHHS Division of Senior Services Title III Budgets as
8 amended, provided that any amendments or modifications shall be submitted
9 for prior approval by the Tohono O'odham Legislative Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
11 day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0-
12 AGAINST; -0- NOT VOTING; and 232.3 [06] ABSENT, pursuant to the powers vested in the Council
13 by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
14 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
15 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
16 Act of June 18, 1934 (48 Stat.984).


