

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Intergovernmental Agreement between the City of Glendale  
and the Tohono O'odham Nation for Detention Services)**

**RESOLUTION NO. 18-052**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**  
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**  
3 **O'odham Nation ("Nation") with Federal, State, and local governments."**  
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

5 **WHEREAS, the Nation provides 24 hour police services to the West Valley Casino and desire**  
6 **to contract with the City of Glendale to provide detention services for the**  
7 **Nation's Police Department servicing the West Valley Casino; and**

8 **WHEREAS, the City of Glendale will supply safekeeping, care and maintenance of persons**  
9 **arrested by the Nation and booked into the City of Glendale's detention system**  
10 **at a rate of \$127.61 per inmate per day; and**

11 **WHEREAS, in the event that the Nation is unable to transport prisoners to the City of**  
12 **Glendale's detention facility, the Nation may request the Glendale Police**  
13 **Department to transport the prisoners at a cost of \$50.00 per transport; and**

14 **WHEREAS, the fees accrued, will be paid by FY 2018 Department of Public Safety, West**  
15 **Valley Resort professional services line item; and**

16 **WHEREAS, the Domestic Affairs Committee of the Legislative Council have reviewed this**  
17 **Intergovernmental Agreement and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
19 **approves Intergovernmental Agreement between the City of Glendale and the**  
20 **Tohono O'odham Nation for the purpose of providing detention services for the**  
21 **Nation's Police Department servicing the West Valley Casino substantially in the**  
22 **form attached hereto.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
24 **the Nation's Chairperson and any designated official to enter into this**  
25 **agreement, provided that any amendments affecting the funds or funding level**  
26 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
27 **Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
29 **day of FEBRUARY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**  
30 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
34 **June 18, 1934 (48 Stat.984).**




