

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting the U.S. Department of Justice Office of Justice Programs Enhance the Sex Offender, Registration, Tracking, Enforcement and Notification Division, SORNA Program Grant 12 Month No Cost Extension, and Approving the FY 2018 Department of Public Safety U.S. Department of Justice Office of Justice Programs Enhance the Sex Offender, Registration, Tracking, Enforcement and Notification Division, SORNA Program Budget)**

**RESOLUTION NO. 18-073**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to  
3 appropriate these funds for the benefit of the nation and its members" provided  
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or  
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety applied for and was awarded the U.S.  
8 Department of Justice Office of Justice Programs Enhance the Sex Offender,  
9 Registration, Tracking, Enforcement and Notification Division, ("SORNA")  
10 Program, Grant Award No. 2015AWBX0011, effective October 1, 2015 through  
11 September 30, 2017, which was accepted by Resolution No. 15-482; and

12 **WHEREAS,** the Department of Public Safety applied for a 12 month no cost extension of  
13 Award No. 2015AWBX0011, effective October 1, 2017 through September 30, 2018,  
14 which was approved; and

15 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and  
16 approval its FY 2018 U.S. Department of Justice Office of Justice Programs  
17 Enhance the SORNA Program Budget, which is incorporated by this reference, in  
18 the amount of \$141,847.12 to be funded by the Nation's general fund pending  
19 reimbursement by the grantor; and

20 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
21 2018 Department of Public Safety U.S. Department of Justice Office of Justice  
22 Programs Enhance the SORNA Program Budget and recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the  
24 U.S. Department of Justice Office of Justice Programs Enhance the SORNA  
25 Program Grant 12 month no cost extension, effective October 1, 2017 through  
26 September 30, 2018.

27 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council approves the FY 2018  
28 Department of Public Safety U.S. Department of Justice Office of Justice  
29 Programs Enhance the SORNA Program Budget in the amount of \$141,847.12,  
30 which shall be funded by the Nation's general fund pending reimbursement  
31 from the grantor.

6 prior approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>  
8 day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
9 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
10 Article VI, Sections 1(d)(2), (d)(3) and (f) of the Constitution of the Tohono O'odham Nation,  
11 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
12 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
13 16 of the Act of June 18, 1934 (48 Stat.984).
