

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Sells District Ge Oidag Community Mining Royalties Budget)**

**RESOLUTION NO. 18-075**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council

11 ; and

12 **WHEREAS,** by Sells District Council Resolution No. SD-06-18, the Sells District has authorized  
13 the FY 2018 Sells District Ge Oidag Community Mining Royalties Budget, which is  
14 incorporated by this reference, in the amount of \$19,813.32; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Sells District Ge  
16 Oidag Community Mining Royalties Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18 FY 2018 Sells District Ge Oidag Community Mining Royalties Budget in the  
19 amount of \$19,813.32.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018 Sells  
21 District Ge Oidag Community Mining Royalties Budget shall be managed and  
22 expended in accordance with Article IX, Section 7 of the Constitution of the  
23 Tohono O'odham Nation and the Nation's laws, provided that any amendments or  
24 modifications shall be authorized under District Council resolution and  
25 submitted for prior approval by the Tohono O'odham Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>th</sup>**  
27 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
32 **(48 Stat.984).**
