

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting the U.S. Department of Justice, Office of Justice Programs Award
No. 2017-AW-BX-0049, "Enhancement of the Tohono O'odham Nation Police
Department's SORNA Program" and Approving the FY 2018 Budget)**

RESOLUTION NO. 18-090

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety, Police Department applied for and was
8 awarded the United States Department of Justice ("DOJ"), Office of Justice
9 Programs ("OJP") "Enhancement of the Tohono O'odham Nation Police
10 Department's SORNA Program," Award No. 2017-AW-BX-0049 in the amount of
11 \$298,077.00; and

12 **WHEREAS,** this grant is effective October 1, 2017 through September 30, 2019; and

13 **WHEREAS,** this budget does not include Indirect Cost (IDC) as the agency will not allow IDC
14 to be charged without a current year IDC agreement; and

15 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
16 approval its FY 2018 DOJ, OJP "Enhancement of the Tohono O'odham Nation
17 Police Department's SORNA Program" Budget in the amount of \$171,191.73,
18 which is incorporated by this reference, and which shall be funded by the
19 Nation's general fund pending reimbursement by the grantor; and

20 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the
21 grant and budget and recommend its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts
23 Award No. 2017-AW-BX-0049, "Enhancement of the Tohono O'odham Nation
24 Police Department's SORNA Program" in the amount of \$298,077.00.

25 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council approves the FY 2018
26 Department of Public Safety DOJ, OJP "Enhancement of the Tohono O'odham
27 Nation Police Department's SORNA Program" Budget in the amount of
28 \$171,191.73 effective October 1, 2017 to be funded by the Nation's general fund
29 pending reimbursement by the grantor.

30 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council authorizes the
31 Tohono O'odham Nation Chairperson or any designated official to seek
32 reimbursement or recoup any IDC expenses in the event IDC rate is
33 subsequently approved by the Interior Business Center.

3 **administer and expend the FY 2018 Department of Public Safety, DOJ, OJP**
4 **"Enhancement of the Tohono O'odham Nation Police Department's SORNA**
5 **Program" Budget, provided however, that any amendments or modifications**
6 **shall be submitted for prior approval by the Tohono O'odham Legislative**
7 **Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
9 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
11 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
12 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
14 **June 18, 1934 (48 Stat.984).**
