

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Chukut Kuk District Tecolote Community Budget Amendment No. 1)

RESOLUTION NO. 18-091

1 **WHEREAS, Pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No District shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation and all expenditure of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council**

11 **; and**

12 **WHEREAS, by Chukut Kuk District Resolution No. 2017-48, the FY 2018 Chukut Kuk District**
13 **Budget in the amount of \$1,976,701.13 was authorized by the Chukut Kuk District**
14 **Council and approved by Legislative Council Resolution No. 17-420; and**

15 **WHEREAS, by Chukut Kuk District Council Resolution No. 2018-06, the Tecolote Community**
16 **has authorized and submitted for review and approval its FY 2018 Budget**
17 **Amendment No. 1, which is incorporated by this reference and which will adjust**
18 **operational and/or personnel line items; and**

19 **WHEREAS, the FY 2018 Chukut Kuk District Tecolote Community Budget Amendment No. 1**
20 **will increase the Tecolote Community Budget by \$4,252.00 from \$40,000.00 to**
21 **\$44,252.00; and**

22 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 Chukut Kuk District**
23 **Tecolote Community Budget Amendment No. 1 and recommends its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **FY 2018 Chukut Kuk District Tecolote Community Budget Amendment No. 1,**
26 **which includes a \$4,252.00 increase from \$40,000.00 to \$44,252.00.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2018 Chukut**
28 **Kuk District Tecolote Community Budget as amended shall be managed and**
29 **expended in accordance with Article IX, Section 7 of the Constitution of the**
30 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
31 **modifications shall be authorized under District Council resolution and**
32 **submitted for prior approval by the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
