

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Professional Services Agreement between the Tohono
O'odham Nation and Intermountain Centers for Human Development, Inc.)**

RESOLUTION NO. 18-095

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to "consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political**
5 **subdivisions, or with private persons or organizations on all matters within the**
6 **authority of the Tohono O'odham Council" (Constitution, Article VI, Section 1(f));**
7 **and**

8 **WHEREAS, Amendment No. 1 to Professional Services Agreement between the Tohono**
9 **O'odham Nation ("Nation") and Intermountain Centers for Human**
10 **Development, Inc. ("Intermountain"), which is incorporated by this reference,**
11 **will allow Intermountain to provide residential and foster care services for the**
12 **Nation's Children In Need of Care for the period of October 1, 2017 to September**
13 **30, 2018; and**

14 **WHEREAS, Amendment No. 1 to Professional Service Agreement between the Nation and**
15 **Intermountain ("the Agreement") has been reviewed by the Office of Attorney**
16 **General as required by law; and**

17 **WHEREAS, the FY 2018 Department of Health and Human Services Division of Child Welfare**
18 **Tribal Child Welfare Budget 001-18-6051 will fund this Agreement; and**

19 **WHEREAS, the Health and Human Services Committee has reviewed the Agreement and**
20 **recommends approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
22 **Amendment No. 1 to Professional Services Agreement between the Tohono**
23 **O'odham Nation and Intermountain Centers for Human Development, Inc. in**
24 **substantially the form attached and authorizes the Tohono O'odham Nation**
25 **chairperson to execute and administer the Agreement.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
27 **day of MARCH, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; ~~0~~**
28 **AGAINST; ~~0~~ NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(c)(2), 1(d)(3), and 1(f) of the Constitution of the Tohono O'odham Nation,**
30 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
